
RESOLUTION NUMBER R- 270029

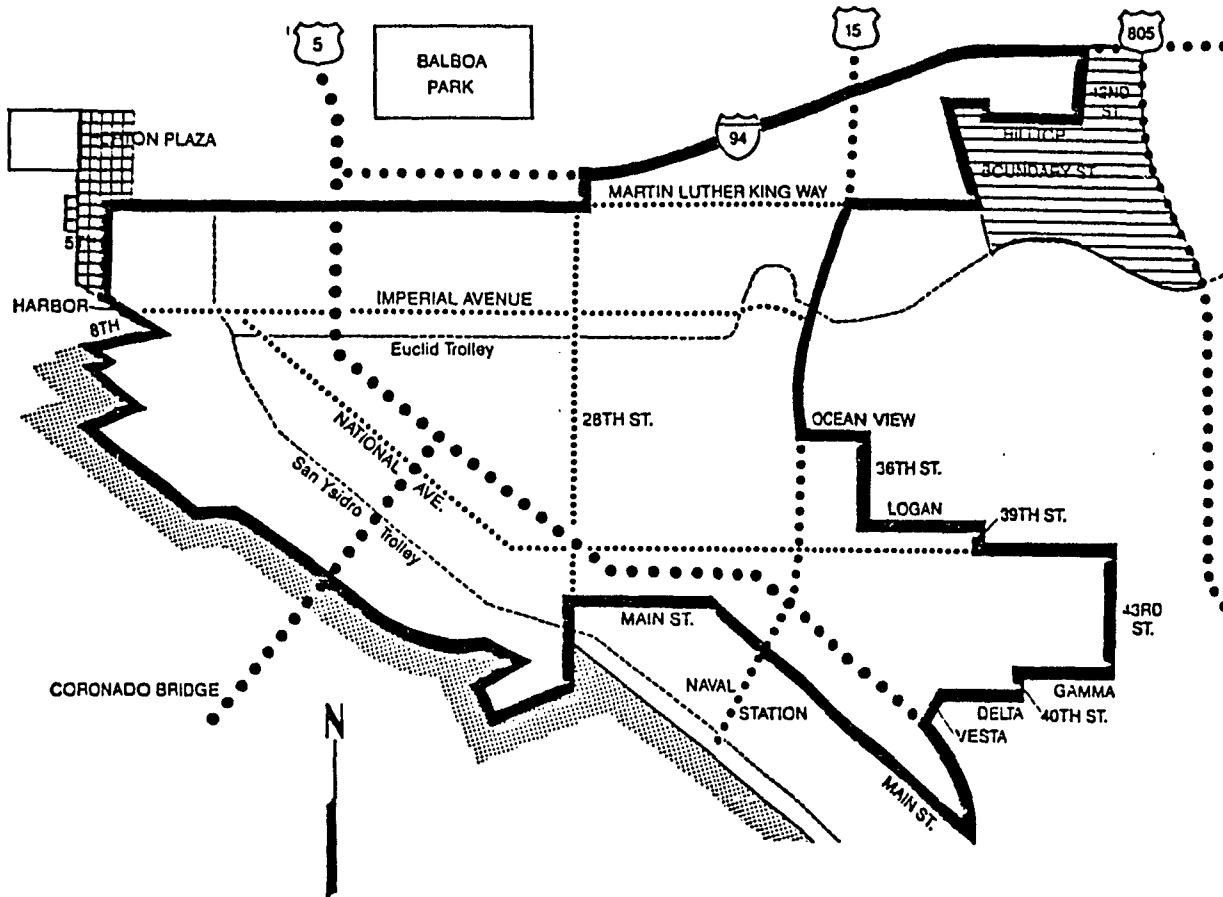

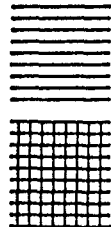
