
ADOPTED ON JAN 4 1988

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$50,000 from C.I.P. No. 52-396.0, State Routes 117 and 125, to C.I.P. No. 52-376.0, Texas Street.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$110,000 from Gas Tax Fund No. 30219, C.I.P. No. 52-376.0, Texas Street, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
