

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$7,000 from PSD Fund 17500 to CIP No. 29-537, Union Circle Park Irrigation Improvements.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$7,000 from CIP No. 29-537, Union Circle Park Irrigation Improvements, PSD Fund 17500 to supplement funds previously authorized by Resolution No. R-263967, adopted September 9, 1985, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
