RESOLUTION NUMBER R- 270086

ADOPTED ON JAN 5 1988

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 22, 1987, to consider the proposed amendment to the MIRA MESA COMMUNITY PLAN (NO. 87-17PA) affecting property on the north and south sides of Carroll Canyon Road, between El Camino Memorial Park and Camino Ruiz, for the purpose of:

1. Redesignating a 487-acre site from extractive industrial to multi-use specific plan and neighborhood park; and

2. Reclassifying Carroll Canyon Road from a six-lane major to a four-lane major, between Maya Linda and Black Mountain Road; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council of said amendment; and

WHEREAS, the Council of The City of San Diego having considered all maps, exhibits, written documents and materials in this matter, having heard all oral presentations given, and being fully advised concerning the same at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby approves the amendment of the MIRA MESA COMMUNITY PLAN (NO. 87-17PA), a copy of which is on file in the office of the City Clerk as Document No. RR- 270086.
