BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the amendment of the CARMEL MOUNTAIN RANCH COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 270090.

2. That the amendment of the CARMEL MOUNTAIN RANCH
COMMUNITY PLAN shall become effective upon adoption of an
appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR
THE CITY OF SAN DIEGO incorporating said plan at the next
scheduled omnibus hearing.
