

RESOLUTION NUMBER R- 270100

ADOPTED ON JAN 11 1988

BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. NEPTUNE WATER METER COMPANY, 2. BADGER METER, INC., 3. KENT METERS, INC., and 4. WESTERN WATER METER CO., INC., meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISCELLANEOUS TURBINE TYPE WATER METERS WITH STRAINERS as may be required for a period of one (1) year beginning November 1, 1987 through October 31, 1988, per prices on file in the Purchasing Department, as follows:

1. NEPTUNE WATER METER COMPANY for Item 1; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed 5% of the prices in effect at the end of the previous contract year.
2. BADGER METER, INC. for Items 2 and 3; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect at the end of the previous contract year, by the following percentages: option year 1 - 1%, option year 2 - 1.5%, option year 3 - 2%, option year 4 - 3.5%.
3. KENT METERS, INC. for Items 4, 5 and 7; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with no price increases in the first option year and the price increases in the second through fourth option years not to exceed 3% of the prices in effect at the end of the previous contract year.
4. WESTERN WATER METER CO., INC. for Item 6; terms 2% 20 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed 10% of the prices in effect at the end of the previous contract period.
