

RESOLUTION NUMBER R- 270101

ADOPTED ON JAN 11 1988

BE IT RESOLVED, by the Council of The City of San Diego that the bids of 1. WESTERN WATER METER CO., 2. BADGER METER, INC., 3. CARLON METER COMPANY, 4. HERSEY PRODUCTS, INC., 5. KENT METERS, INC., 6. NEPTUNE WATER METER COMPANY, and 7. ROCKWELL INTERNATIONAL, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of MISC. REPLACEMENT WATER METER PARTS as may be required, for a period of one (1) year beginning November 1, 1987 through October 31, 1988, as follows:

1. WESTERN WATER METER CO. - Item No. 1, at 10% discount from manufacturer's list price; terms 2% 20 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect at the end of the previous contract years, by the following percentages: option years 1 and 2 - 2%, option years 3 and 4 - 5%.
2. BADGER METER, INC. - Item No. 2, at 37% discount from manufacturer's list price; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods with option year price increases not to exceed the prices in effect at the end of the previous contract years, by the following percentages: option year 1 - 1%, option year 2 - 1.5%, option year 3 - 2.5%, option year 4 - 3%.
3. CARLON METER COMPANY - Item No. 3, at 10% discount from manufacturer's list price, F.O.B. Grand Haven; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect at the end of the previous contract years by 10% for option years 1 through 4.
4. HERSEY PRODUCTS, INC. - Item No. 4, at manufacturer's list price, F.O.B. Los Angeles, with full freight allowed on orders of \$1,000.00 and over; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect at the end of the previous contract years by 6% for option years 1 through 4.

KENT METERS, INC. - Item No. 5, at 25% discount from manufacturer's list price; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods, with option year price increases not to exceed the prices in effect at the end of the previous contract years, by the following percentages: option year 1 - 0%, option year 2 - 3%, option year 3 - 5%, option year 4 - 6%.
6. NEPTUNE WATER METER COMPANY - Item No. 6, at 15% discount from manufacturer's list price; terms net 30 days, plus applicable California sales tax, with options to renew contract for four (4) additional one (1) year periods at the same percentage discount on updated manufacturer's list prices.
7. ROCKWELL INTERNATIONAL - Item No. 7, at 10% discount from manufacturer's list price; terms net 30 days, plus applicable California sales tax.
