APPROVING MAP OF MIRADOR PARK UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Hans Peter Craig, Licensed Land Surveyor, entitled "MIRADOR PARK UNIT NO. 2 being a subdivision of portions of Parcels 4, 5, 6 and 7 of Parcel Map No. 14629, filed in the office of the County Recorder, and portions of Rancho Los Penasquitos, according to Map accompanying the patent to said Rancho, recorded in the office of the County Recorder of San Diego County, in Book 2, Page 385 of Patents, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Norcanyon Way, River Rim Road, Thomas Hayes Lane, Meyncke Way, Winans Cove, Del Rim Court, Hagans Circle, Landbreeze Way and Badami Circle and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Calle

Cristobal, adjacent and contiguous to Lots 80, 81 and 152, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on the map within the subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the easements for open space over, upon or across all those portions of Lots 6 through 11, inclusive, 49 through 54, inclusive, 56, 57, 62 through 67, inclusive, and 150, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as well as the open space easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
