



BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a 5-year lease agreement with IMMIGRATION AND NATURALIZATION SERVICE - WESTERN REGIONAL OFFICE, for office space in Building 2002 and three aircraft tie-down spaces at Brown Field Airport, at an annual rent of \$6,312 plus 4 cents per gallon of fuel delivered to the airport for lessee's use, under the terms and conditions set forth in that lease agreement on file in the office of the City Clerk as Document No. RR- 270122.
