WHEREAS, the City Council adopted Resolution No. R-269952 on December 7, 1987, appointing Councilmembers to serve as representatives and liaisons to various organizations; and

WHEREAS, item number 28 on the list of committees, entitled "SB 2505 Implementation Advisory Committee - (Jails/Courts Facilities)" was inadvertently identified and is inconsistent with the State code creating such body; and

WHEREAS, it is now deemed necessary and appropriate to correct the name of the Board and appointment and rescind the existing listing of item number 28 as listed on Resolution No. R-269952; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that Board listing and appointments listed under item number 28 on Resolution No. R-269952, entitled "SB 2505 Implementation Advisory Committee - (Jails/Courts Facilities)" be and the same is hereby rescinded.

BE IT FURTHER RESOLVED, that item number 28, discussed above, be corrected and retitled "SAN DIEGO COUNTY REGIONAL JUSTICE FACILITY FINANCING AGENCY, BOARD OF DIRECTORS" and that Councilmember Gloria D. McColl be and she is hereby appointed to said Board of Directors of the San Diego County Regional Justice Facility Financing Agency, to represent The City of San Diego,

with all the rights, duties and powers appurtenant thereto effective December 7, 1987, pursuant to the provisions of California Government Code sections 26260 and 26261(a)(2).
