

RESOLUTION NUMBER R- **270138**

ADOPTED ON JAN 12 1988

WHEREAS, on July 7, 1987, the Council of The City of San Diego adopted the UNIVERSITY COMMUNITY PLAN and directed the Planning Department to apply the Community Plan Implementation Overlay Zone Type "B" (CPIOZ "B") to those areas and properties not otherwise subject to discretionary review and to provide additional development guidelines for these areas; and

WHEREAS, on October 29, 1987, the Planning Commission recommended approval of an amendment to the UNIVERSITY COMMUNITY PLAN providing additional development guidelines for and applying CPIOZ "B" to those properties in Subareas 5, 9, 10, 67, 86, 96, 97, 98 and 99; and

WHEREAS, the Council held a public hearing to consider an amendment to the UNIVERSITY COMMUNITY PLAN providing additional development guidelines for, and applying CPIOZ "B" to those properties in Subareas 5, 9, 10, 67, 86, 96, 97, 98 and 99; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby adopts development guidelines on file in the office of the City Clerk as Document No. RR- **270138**, to be added to the UNIVERSITY COMMUNITY PLAN for those properties designated on Zone Map Drawing No. C-751.2 (Subareas 5, 9, 10, 67, 86, 96, 97, 98 and 99.
