A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ESTABLISHING DEPOSITS AND FEES FOR PROCESSING REQUESTS MADE PURSUANT TO THE INTERIM DEVELOPMENT ORDINANCE.

WHEREAS, the Planning Commission conducted a noticed public hearing on December 17, 1987, to establish fees and deposits for The City of San Diego ("City") services to defray costs associated with requests for processing applications within the parameters of the Interim Development Ordinance ("IDO"); and

WHEREAS, the Planning Commission has recommended a cost recovery program to the Council of The City of San Diego ("Council"); and

WHEREAS, the Council has directed that fees and deposits for City services are to be cost recoverable; and


WHEREAS, the Council conducted a noticed public hearing on January 12, 1988, and enacted legislation authorizing fees/deposits for processing applications pursuant to the IDO;
