WHEREAS, the San Diego-Imperial Counties Labor Council has been effectively meeting the needs of organized labor in San Diego since 1902; and


WHEREAS, the more than 100 affiliated labor groups within San Diego and Imperial Counties represent approximately 120,000 union members; and
