RESOLUTION NUMBER R- 270163

ADOPTED ON JAN 19 1988

WHEREAS, by Resolution No. R-267267 adopted on December 15, 1986, this Council provided that the vacation of a portion of Black Mountain Road and a portion of Mercy Road in conjunction with Mercy Mira Mesa, TM 85-0299 would occur only after the rededication of Mercy Road within Mercy Mira Mesa Subdivision (TM 85-0299) has been approved by Council action, and that in the event the dedication of the realignment for Mercy Road is not approved by June 13, 1987, this Resolution shall become void and be of no further force or effect; and


WHEREAS, the abutting property owner has requested a time extension in order to complete the rededication for the realignment of Mercy Road required by Resolution No. R-267267 subject to City Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Item 2 of Resolution No. R-267267, adopted December 15, 1986, which is on file in the office of the City Clerk, be and the same is hereby ordered amended as follows: "That this Resolution shall not become effective unless and until the rededication for the realignment of Mercy Road within Mercy Mira Mesa (TM 85-0299) has been approved by Council action. In the event that the dedication for the realignment of Mercy Road is not approved by June 13, 1989, this Resolution shall become void and be of no further force or effect."

2. That the City Engineer shall advise the City Clerk of Council approval of the rededication of Mercy Road, and that the City Clerk shall then cause a certified copy of this Resolution and Resolution No. R-267267, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
