WHEREAS, Mr. Dennis P. Long has served as volunteer Chairman of the World USO Board of Governors since 1984; and

WHEREAS, Dennis P. Long has consistently demonstrated his personal commitment to serve the human needs of our American men and women in uniform, along with their families, who so diligently serve our nation to ensure global peace; and

WHEREAS, Mr. Long has given unselfishly of his time, talent, energy and personal resources to spearhead the revitalization and expansion of USO's mission and programs and has nurtured a closer and more vital relationship between military personnel and civilian communities here in the United States as well as overseas; and

WHEREAS, Mr. Long's expertise in corporate management and private fundraising were critical assets and contributed significantly to the USO's ability to continue vital assistance to the military community; and

WHEREAS, for this exceptional dedication to the military community, Mr. Long was presented with the Secretary of Defense Medal for Outstanding Public Service, the highest honor bestowed on a civilian by the Department of Defense; and


WHEREAS, under Mr. Long's leadership, Anheuser-Busch, Inc., the world's largest brewer, has been an active corporate citizen supporting a wide range of USO programs in the United States and abroad; and

WHEREAS, in the past year alone, over \$1,350,000 in contributions and challenge grants have been offered; and

WHEREAS, in the past three years, Anheuser-Busch has also provided valuable in-kind support for USO activities which have greatly improved the structure, business management, financial reporting and fundraising capabilities of the USO and has spearheaded efforts to improve awareness and marketing programs of USO through sponsorship of promotional materials, fundraising events and encouraging volunteer support from its wholesaler network; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby recognizes the distinctive contributions of Dennis P.
