RESOLUTION NUMBER R- 270189

ADOPTED ON JAN 19 1988

WHEREAS, the President's Commission on Americans Outdoors (PCAO) has issued its final report containing strategies and recommendations for public and private initiatives in parks, recreation, conservation and allied areas; and

WHEREAS, this report represents the most comprehensive analysis of American recreation and park needs in a quarter of a century; and

WHEREAS, the outdoor heritage, preservation and protection proposals in the PCAO document will not be realized unless nationwide and local advocacy is implemented to ensure action on the recommendations; and

WHEREAS, state and local governments need a forum to advocate for the availability of state and federal funding and legislation that will support the implementation of the PCAO's recommendations; and

WHEREAS, cities have a vital interest in preserving outdoor resources and to promote recreation as one of the aspects of the quality of life for its citizens; and

WHEREAS, the Rules Committee reviewed Intergovernmental Relations Department (IRD) Report No. 87-29 on January 6, 1988, which described the work of the PCAO and its importance to The City of San Diego and approved the recommendation unanimously;
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation of the President's Commission on Americans Outdoors final report be and the same is hereby endorsed.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of said City, hereby calls for Congressional hearings to be held on the implementation of the recommendations of the report.

BE IT FURTHER RESOLVED, that the Mayor be and she is hereby requested to introduce the resolution attached to IRD Report No. 87-29 at the U.S. Conference of Mayors' meeting on January 20-23, 1988, in Washington, D.C.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of said City, hereby expresses its support for legislation proposed by Congressman Morris Udall which would implement PCAO's recommendations.
