RESOLUTION NUMBER R- 270190

ADOPTED ON JAN 19 1988

WHEREAS, on January 6, 1988, the Rules Committee reviewed legislative proposals, described in Intergovernmental Relations Department (IRD) Report No. 87-28, which would provide immunity from liability for members of advisory boards and eliminate the Enterprise Zone requirement that a "qualified employee" perform at least fifty percent (50%) of the person's services in the zone; and

WHEREAS, IRD Report No. 87-28 recommended that the City sponsor such legislation; and

WHEREAS, the Intergovernmental Relations Department also recommended that the City support measures by Senators Garamendi and Klehs and Assemblyman Nolan to modify existing state law related to Enterprise Zones and tax regulations; and

WHEREAS, the Rules Committee unanimously approved the recommendations contained in IRD Report No. 87-28; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the legislative proposals set forth in IRD Report No. 87-28, dated December 31, 1987, be and the same are hereby approved for inclusion in The City of San Diego's 1988 Legislative Sponsorship Program.

BE IT FURTHER RESOLVED, that the City's Department of Intergovernmental Relations be and it is hereby directed to

support legislation by Senators Garamendi and Klehs and  
Assemblyman Nolan as described in IRD Report No. 87-28.
