RESOLUTION NUMBER R- 270191

ADOPTED ON JAN 19 1988

WHEREAS, Assemblymember Byron Sher has introduced AB 612 into the California State Legislature; and

WHEREAS, AB 612 would broaden the scope of the California Beverage Container Recycling and Litter Reduction Act, adopted by the Legislature in 1986, and would provide that "wine coolers," as defined within AB 612, would be included within the definition of "beverage," for purposes of the California Beverage Container Recycling and Litter Reduction Act; and

WHEREAS, the inclusion of wine coolers as "beverages" is a logical and equitable way to increase the effectiveness of the California Beverage Container Recycling and Litter Reduction Act; and

WHEREAS, the adoption of AB 612 would help reduce roadside litter and litter in public places throughout the State of California, and would also increase the ability of the State of California to recycle and reuse important and valuable materials; and

WHEREAS, the adoption of AB 612 would be to the advantage of all Californians and to the citizens of The City of San Diego; and


