RESOLUTION NUMBER R- 270192

ADOPTED ON JAN 19 1988

WHEREAS, sewage and toxic pollution originating in Mexico and crossing the international border has created a threat to the health and safety of the people of the State of California; and

WHEREAS, the flow of raw sewage from Tijuana, Mexico is continuing to enter The City of San Diego in ever increasing amounts; and


WHEREAS, additional federal funding has not been authorized to solve this problem; and

WHEREAS, AB 930 (Brown) would enact the International Border Wastewater and Toxics Cleanup Bond Act to place on the ballot a State General Obligation Bond issue of \$150 million to finance facilities to mitigate, reduce or reverse the effects of pollution and contamination on the international border; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby expresses and declares its strong support for AB 930 (Brown).

BE IT FURTHER RESOLVED, that the Director of the Intergovernmental Department be and she is hereby authorized to send a letter with a copy of this resolution to Assembly Speaker Brown, indicating the City's strong support for AB 930.
