ADOPTED ON JAN 25 1988

WHEREAS, The City of San Diego entered into an Agreement with Physicians and Surgeons Hospital, filed in the Office of the City Clerk as Document No. RR-262486-2, pursuant to which the hospital was to render its services in connection with the performance of evidentiary examinations for the San Diego Police Department; and

WHEREAS, The City of San Diego entered into an Agreement with Sharp Cabrillo Hospital, filed in the Office of the City Clerk as Document No. RR-262486-1, pursuant to which the hospital was to render its services in connection with the performance of evidentiary examinations for the San Diego Police Department; and

WHEREAS, the above Agreements were to expire on December 31, 1987; and

WHEREAS, the California State Legislature enacted Penal Code sections 13823.5 through 13823.11 to govern certain evidentiary examinations; and

WHEREAS, the Office of Criminal Justice Planning established statewide protocols for the performance of certain evidentiary examinations; and

WHEREAS, the County has not completed action under the statutes to designate hospitals to conduct the evidentiary examinations under the protocols; and

WHEREAS, the City desires to extend the existing contracts with amendments to conduct the requisite examinations for an


interim period in accordance with the statewide protocols; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that
the City Manager be and he is authorized and empowered to
execute, for and on behalf of said City, amendments to the
existing Agreements with Physicians and Surgeons Hospital and
Sharp Cabrillo Hospital for the interim provision of evidentiary
examinations, under the terms and conditions set forth in the
Agreements on file in the Office of the City Clerk as Documents
Nos. RR- 270220-1 and RR- 270220-2 respectively.

BE IT FURTHER RESOLVED, that the City Manager of The City of
San Diego is hereby authorized to expend not more than \$100,000
solely and exclusively for evidentiary examinations for the San
Diego Police Department.
