APPROVING PARCEL MAP NO. T.M. 86-0244.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Gary L. Hay, Registered Civil Engineer, entitled "PARCEL MAP NO. T.M. 86-0244 being a division of portions of Lots 'J' and 'K' of Shaw Addition to Encanto Heights, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 1227, filed in the office of the County Recorder of San Diego County, January 10, 1910," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication those portions of Parcels 1 and 2 marked "Reserved for Future Streets," as shown on this map, under the provisions of Section 66440 of the Government Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress for the construction and maintenance of slopes, as granted and shown on said parcel map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council, and that said Council has approved said parcel map, and that said Council had rejected a portion of Parcels 1 and 2, marked "Reserved for Future Street," together with the easements with the right of ingress and egress for the construction and maintenance of slopes, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
