
ADOPTED ON FEB 2 1988

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$36,000.00 from Fund 18517, C.I.P. No. 52-285, "Street and Alley Improvements in CDBG areas," and \$4,000.00 from Fund 41506, C.I.P. No. 44-001, "Sewer Main Replacement Annual Allocation" is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
