RESOLUTION NUMBER R- 270264

ADOPTED ON FEB 2 1988

WHEREAS, the Council of The City of San Diego desires to implement San Diego Municipal Code Section 26.07, which created the Commission for Arts and Culture, especially subsection C. (Duties and Functions), relating to advising the City upon acquisition and placement of works of art on City property and review of proposals for removing works of art from City property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager shall provide the Commission for Arts and Culture an inventory of City-owned land and buildings so that the Commission for Arts and Culture may evaluate sites to determine feasibility for locating works of art.

BE IT FURTHER RESOLVED, that the City Manager shall provide the Commission for Arts and Culture copies of the Capital Improvement Program (CIP) annually, beginning with FY 1989, for use by the Commission for Arts and Culture as the basis for their annual planning process to recommend locations for works of art, and the City Manager shall work with the Commission for Arts and Culture and the selected artist so that the work of art is incorporated into the approved site design.

BE IT FURTHER RESOLVED, that the City Manager shall send proposals for removing any work of art from public places of the City property, as defined in San Diego Municipal Code Section

26.07.2 (J.), to the Commission for Arts and Culture for advisory review and comment prior to Council action.
