

RESOLUTION NUMBER R- 270273

ADOPTED ON FEB 2 1988

WHEREAS, the Planning Commission of The City of San Diego held a public hearing on October 15, 1987, to consider the proposed UPTOWN COMMUNITY PLAN and amendment of the General Plan Map in order to retain consistency between said plans; and

WHEREAS, the Planning Commission approved and recommended adoption by the City Council the UPTOWN COMMUNITY PLAN; and

WHEREAS, Council Policy 600-7 provides that public hearings to consider revisions of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO may be scheduled concurrently with public hearings on proposed community plans; and

WHEREAS, Government Code Section 65361 provides that mandatory elements of the GENERAL PLAN may not be amended more than four times per year; and

WHEREAS, it is the intention of the City Council to consider amendments of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO at hearings conducted on a semiannual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the PROGRESS GUIDE AND GENERAL PLAN during the year, but such changes shall not become effective until enacted at the semi-annual hearings conducted for the purpose of amending the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the UPTOWN COMMUNITY PLAN and, by a majority vote, approved said plan as modified by the City Council; and

WHEREAS, all matters in the City Clerk's memorandum are to be handled by the Planning Department as revisions to the document to be presented to the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That this Council hereby approves the UPTOWN COMMUNITY PLAN, a copy of which is on file in the office of the City Clerk as Document No. RR- 270273.

2. That the UPTOWN COMMUNITY PLAN shall become effective upon adoption of an appropriate amendment of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO incorporating said plan at the next scheduled omnibus hearing.
