APPROVING MAP OF MERCY MIRA MESA UNIT NO. 2.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Reginald Dale Harvey, Jr., Licensed Land Surveyor, entitled "MERCY MIRA MESA UNIT NO. 2 being a subdivision of a portion of Parcel 2 according to Parcel Map No. 12296, filed in the office of the County Recorder of San Diego County, August 27, 1982, and a portion of Parcel 1 according to Parcel Map No. 14491, filed in the office of the County Recorder of San Diego County September 30, 1986 in the City of San Diego, County of San Diego, State of California, together with that portion of Mercy Road as vacated and closed to public use together with Mercy Road, Chabola Road and Babauta Road as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Babauta Road, Chabola Road and Hito Court and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the easements with the right of ingress and egress of emergency vehicles and for the construction and maintenance of drainage, water and sewer facilities, as granted and shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the open space easement over, upon or across all of Lots 155 and 158, and a portion of Lot 159, designated as "Open Space Easement Granted Hereon," as granted and shown on the map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across all of Lot 156 and a portion of Lot 159, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated, together with the easements with the right of ingress and egress for emergency vehicles and the construction and maintenance of sewer, water and drainage facilities, as well as the building restricted and open space easements, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
