BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$74,900 (\$65,000 from CIP No. 62-282, 54th Street Guardrail and \$9,900 from CIP No. 64-004, Annual Allocation - Railroad Warning Devices to CIP No. 62-300, Signal Timing Optimization Program, Phase 4).
