WHEREAS, Bob Payne was one of five organizers of Grossmont Bank and presently serves as its chairman of the board; and

WHEREAS, Bob Payne's most recent business venture is the new, 350-room Doubletree Hotel in the heart of Mission Valley's commercial district; and

Whereas, Bob Payne has spent countless hours serving his community assisting such civic organizations as the Boys Clubs of San Diego, where he served as president, the San Diego Sports Association, vice-president of the Holiday Bowl, the President's Council at San Diego State, member of the Aztec Golden Ring and vice-chairman of the Gateway Complex; and

WHEREAS, among the many honors he has received are the "Good Guy" award from the Leukemia Society, the School of Business Distinguished Alumni Award from San Diego State and the Golden Man and Boy Award from the Boys Clubs; and


