BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Olive Avenue, Peach Avenue, Eighth Street, and portions of Murphy Canyon Road and Aero Drive, all within the Stonecrest Subdivision (TM 87-0692) boundaries, as more particularly shown on the attached Exhibit "A", on file in the office of the City Clerk as Document No. RR- 270336-1, which is by this reference incorporated herein and made a part hereof,

be and the same is hereby ordered vacated as provided under Section 66499.20} of the California Government Code.

- 2. That the resolution shall not become effective unless and until the final subdivision map for Stonecrest Subdivision (TM 87-0692) has been approved by Council action. In the event that the final map is not approved within six (6) years of the adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, with Exhibit "A", attested by him under seal, to be recorded in the office of the County Recorder.


