



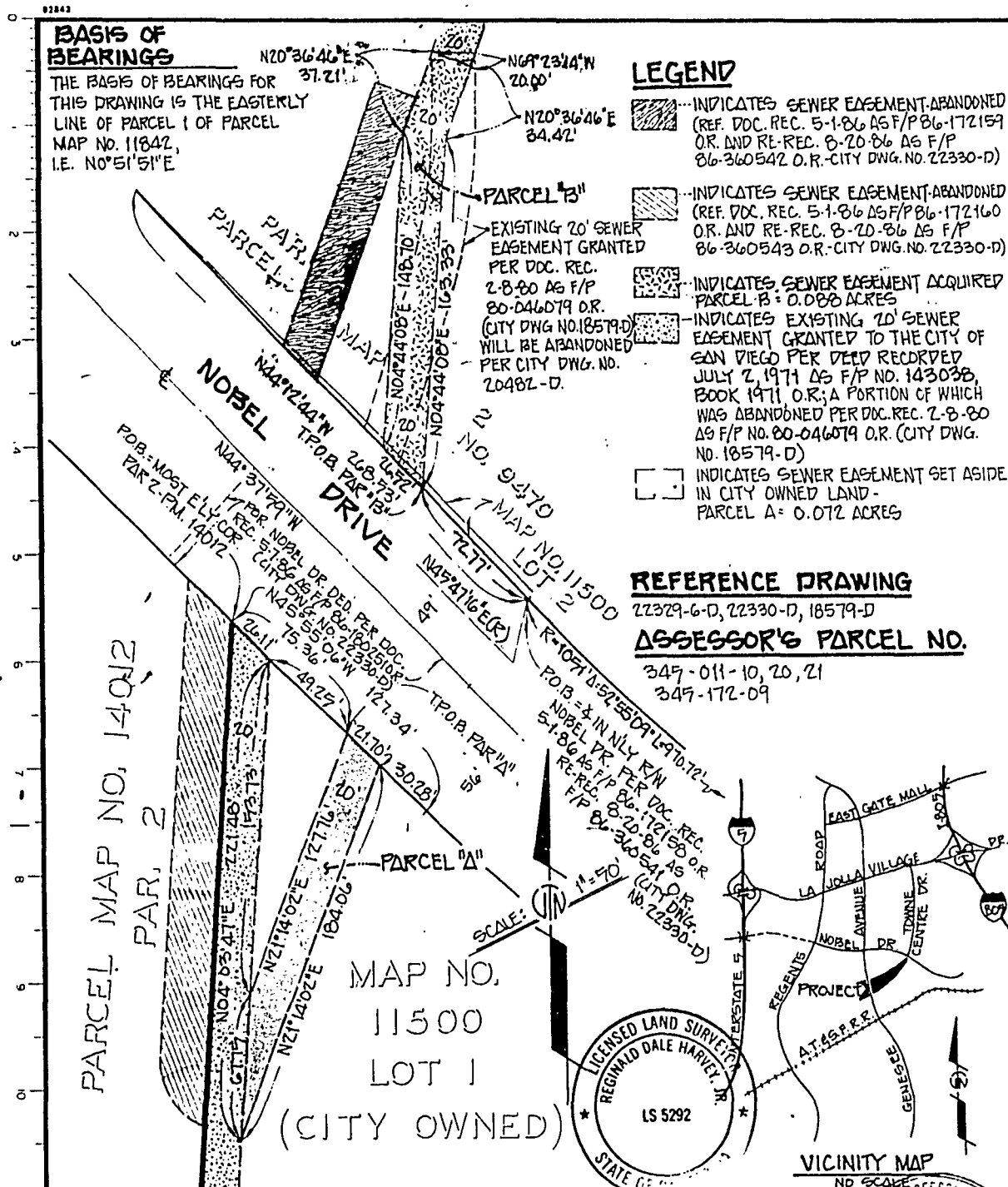
ADOPTED ON FEB 16 1988

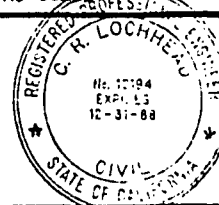
