Duane Zimmerman	Utilities	\$263.95	Mr. Zimmerman is a Lead Operator with the Metro Division. He suggested the use of Hoppers to dispose of screenings. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Anthony Atkins	Police	\$ 90.00	Mr. Atkins is a Police Officer II. He suggested the removal of the automatic fill button on gas pumps. Although savings are difficult to identify, this was considered to be a significant safety improvement.
James Youngs	Fire	\$ 45.00	Mr. Youngs is an Engineer. He suggested the color coding hose couplings on brush apparatus. Although savings are difficult to identify, this was considered to be a significant operational improvement.
Robert Sherer	Police	\$ 25.00	Mr. Sherer is a Stock Clerk with Northern Division. He suggested the use of a narcotics locker for latent print cards. Although savings are difficult to identify, this was considered to be a significant operational improvement.
