
ADOPTED ON FEB 22 1988

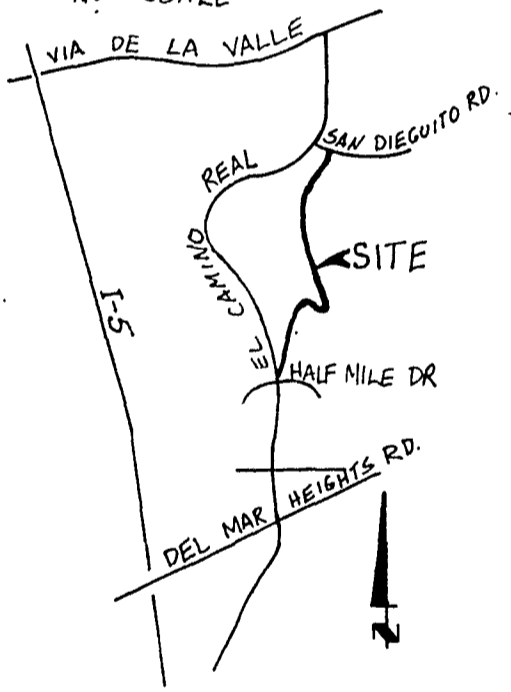

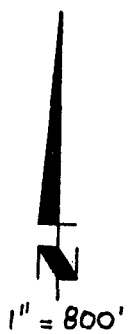
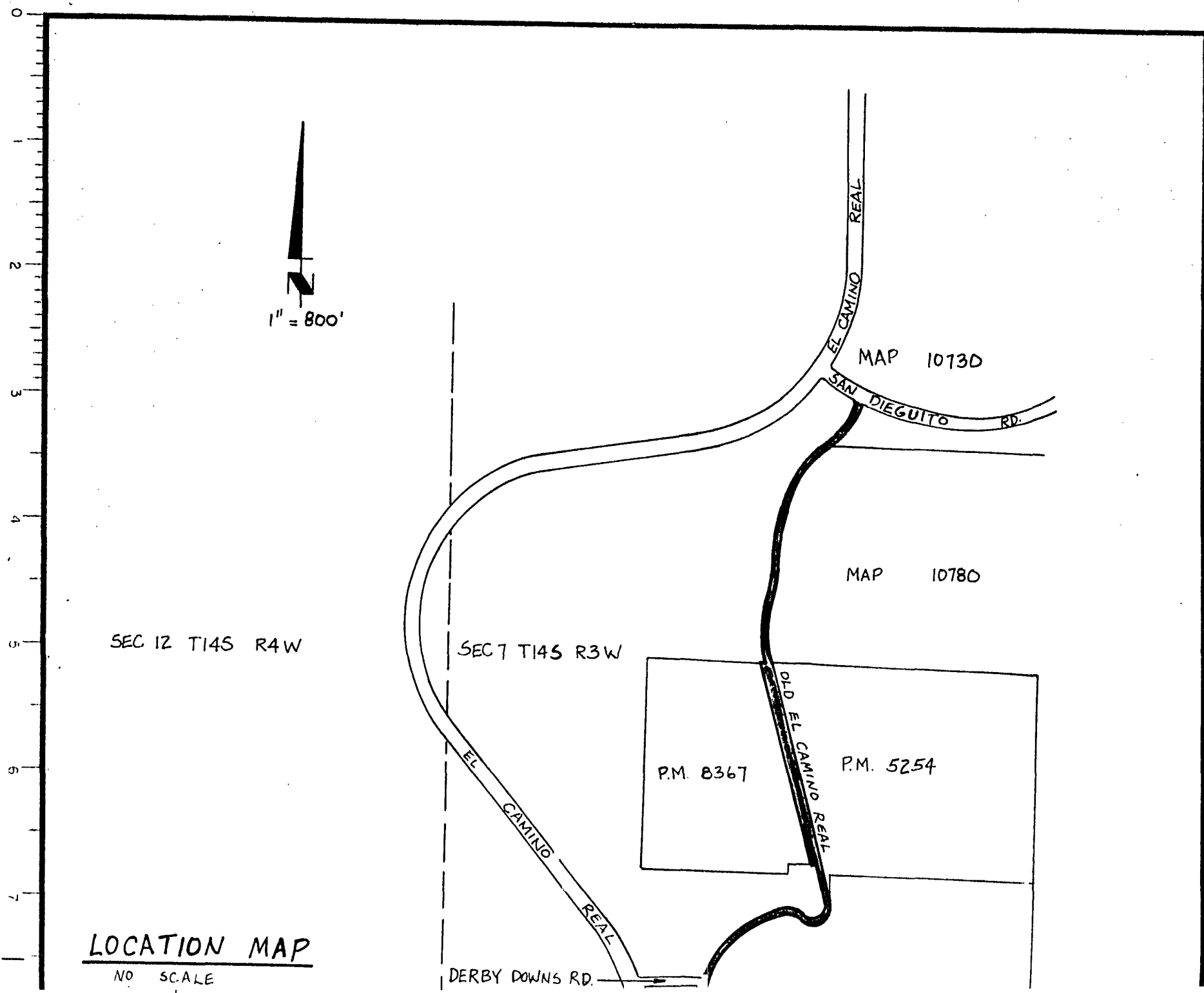
