RESOLUTION NUMBER R- 270396

ADOPTED ON FEB 22 1988

WHEREAS, on May 5, 1987 at a joint City Council/Board of Supervisors meeting to discuss jail overcrowding, Council by Resolution No. R-268290 supported the concept of legislation to permit raising the sales tax by simple majority vote for the purpose of constructing and operating justice facilities; and

WHEREAS, the San Diego County Regional Justice Financing Act, AB2505 (Stirling) Chapter 1258, allows for up to a half-cent increase in the local sales tax for a term not to exceed 10 years, for development of regional justice facilities; and


WHEREAS, on February 3, 1988, the Rules Committee reviewed IRD Report #88-3 which recommends supporting the ballot proposition to add an additional 1/2 cent to the sales tax in San Diego County for a term not to exceed ten years to provide revenue to fund regional jails, probation honor camps, courts and court support facilities; and

WHEREAS, on February 3, 1988, the Rules Committee recommended supporting the ballot proposition contained in IRD Report #88-3; and

WHEREAS, it is now deemed appropriate to forward the matter to the full Council for approval thereof; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in IRD Report #88-3 to support the San Diego County Regional Justice Facility Financing Agency Proposed Ballot Proposition be and the same is hereby adopted.
