BE IT RESOLVED, by the Council of The City of San Diego that the low bids of 1. MIRAMAR FORD TRUCK SALES, INC., 2. E-W TRUCK & EQUIPMENT CO., INC., 3. REYNOLDS BUICK GMC, 4. FULLER FORD, 5. LOS ANGELES FREIGHTLINER, 6. DION INTERNATIONAL TRUCKS, INC., 7. PACIFIC FORD INC. and 8. PACIFIC FREIGHTLINER, meeting specifications, are hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of MEDIUM AND HEAVY DUTY TRUCKS, as follows:

1. MIRAMAR FORD TRUCK SALES, INC. for Item 1 - four (4) each cab and chassis 20M84 (Ford F600) at a cost of \$14,840.00 each; Item 2 - seven (7) each cab and chassis 20M102-2 (Ford F600) at a cost of \$15,725.00 each; Item 3 - five (5) each cab and chassis 22M84-2 (Ford F700) at a cost of \$18,412.00 each; Item 7 - two (2) each cab and chassis 24M102-2 (Ford 700) at a cost of \$18,495.00 each; Item 8 - one (1) cab and chassis dump truck 5 cubic yard (Ford F700 with dump body and hoist) at a cost of \$32,725.00; for a total combined cost of \$331,210.00; terms net 15 days, plus sales tax.
2. E-W TRUCK & EQUIPMENT CO., INC. for Item 4 - four (4) each cab and chassis 22M102-2 (Mack MS200P) at a cost of \$27,350.00 each, for a total cost of \$109,400.00; terms net, plus sales tax.
3. REYNOLDS BUICK GMC for Item 5 - one (1) each cab and chassis 28M84 (4X4) (GMC C7D042) at a cost of \$29,900.00; terms net, plus sales tax.
4. FULLER FORD for Item 6 - thirty (30) each cab and chassis with dump truck 3 cubic yard (Ford F700 with Crysteel dump body and hoist) at a cost of \$21,633.00 each, for a total cost of \$648,900.00; terms net, plus sales tax.
5. LOS ANGELES FREIGHTLINER for Item 9 - one (1) each cab and chassis with dump truck 12 cubic yard (Freightliner #11264) at a cost of \$66,198.45; terms net, plus sales tax.
6.
