RESOLUTION NUMBER R- 270402

ADOPTED ON FEB 22 1988

WHEREAS, the City Council, at its November 23, 1987 meeting, referred to the Citizens' Equal Opportunity Commission, for review, the City Manager's recommended 1988 Minority and Woman Business Enterprise contracting goals; and

WHEREAS, on January 5, 1988, the Citizen's Equal Opportunity Commission (CEOC) conducted a noticed public hearing on the establishment of these goals; and

WHEREAS, in accordance with City Charter sections 35 and 94, the CEOC's recommendations are not for establishing quotas or "set asides" but is used as a measure by which the City's progress in achieving equitable participation for women and minorities in contracting activities can be gauged; and

WHEREAS, The City of San Diego has made significant progress in bringing minorities and women into full economic participation whereby the City has either met or nearly met each of the current goals; and

WHEREAS, the goals recommended for 1988 set the standard of performance another notch higher; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager's recommendation to increase Minority and Women Business Enterprise contracting goals be and is hereby approved.
