BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Kenneth J. Discenza, Registered Civil Engineer, entitled "ALTA DEL MAR P.R.D. UNIT NO. 2 being a subdivision of Parcel 1, of Parcel Map No. 14512, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, October 16, 1986, together with easements recorded January 8, 1987, as File No. 87-007181 of official records all as abandoned in accordance with the provisions of Section 66499.20 1/2 of the Subdivision Map Act," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



That said Council hereby accepts on behalf of The City of San Diego, the building restricted easements over, upon or across a portion of Lots 24 through 32, inclusive, as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivisions map, and that those easements listed in Paragraphs 1 and 2 of the Owner's Certificate, as well as the building restricted easement, as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the County Recorder of the County of San Diego, California.
