BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to set aside a portion of City-owned land, being a portion of Rancho De Los Penasquitos, as more particularly shown on Drawing No. 23880-D attached hereto as Exhibit A and by this reference incorporated herein, for general utilities, slope, drainage and public street easement purposes; and the land set aside for public street purposes is hereby dedicated as and for a public street and the same is hereby named SORRENTO VALLEY BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
