

RESOLUTION NUMBER R- 270467

ADOPTED ON MAR 01 1988

WHEREAS, in December, 1987, The City of San Diego initiated by Council resolutions R-268716 and R-254490 annexation of the 425 acre unincorporated property known as the Scripps Miramar Ranch County Island annexation; and

WHEREAS, Council Resolution No. R-268716 specifies that Pomerado Road shall be closed upon annexation of the county island to the City and shall not reopen until Alternative 8A (south Poway Parkway) is completed as a paved four-lane road from Pomerado Road to Interstate 15; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City proceed with the processing of the Scripps Miramar Ranch (County Island) annexation.

BE IT FURTHER RESOLVED, that prior to any action being taken by this Council to change Pomerado Road from two traffic lanes to four traffic lanes, there first must be an advisory vote or referendum in the Scripps Ranch Community, conducted by the City at its expense, to address such change.

BE IT FURTHER RESOLVED, that notwithstanding the fact that the improvements have been completed to Pomerado Road in the Scripps Miramar Ranch (County Island) annexation area, Pomerado Road shall not be reopened (i.e. connected through to the City of Poway) until the road known as Alternative Alignment 8A has been completed and opened to vehicular traffic.
