WHEREAS, students from both sides of the border may collaborate on joint projects and, in 1987, 2,630 students and 123 teachers participated; and

WHEREAS, in addition to institutional support, the History

Fair requires community support in the amount of \$20,000 and the

City of San Diego has been requested to lend its support; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$20,000 within the General Fund 100 from the Unallocated Reserve (605) to the Allocated Reserve (901) to be used solely and exclusively for defraying expenses relating to the joint San Diego - Tijuana International History Fair.
