RESOLUTION NUMBER R- 270484

ADOPTED ON MAR 07 1988

WHEREAS, The City of San Diego is the owner of portions of Section 12, Township 18 South, Range 2 East, S.B.B.M.; and

WHEREAS, the City desires to negotiate the sale of said land to the STATE OF CALIFORNIA (CalTrans), under the provisions of Section 22.0902 of the San Diego Municipal Code, which permit the sale of real property belonging to The City of San Diego by negotiation; and

WHEREAS, the sale of such real property as this may reasonably be accomplished by negotiation; and

WHEREAS, the value of the property to be conveyed by the City, as determined by CalTrans and City staff, is TEN THOUSAND FIVE HUNDRED FIFTY DOLLARS (\$10,550); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. RR- 270484-1, be, and the same is hereby authorized to be sold by negotiation for the amount of TEN THOUSAND FIVE HUNDRED FIFTY DOLLARS (\$10,550) to the STATE OF CALIFORNIA.


2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. RR-270484-1 granting to the STATE OF CALIFORNIA all those portions of Section 12, Township 18 South, Range 2 East, S.B.B.M., as more particularly described in said grant deed.

3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Right-of-Way Contract with the STATE OF CALIFORNIA, in connection with the above property, under the terms and conditions set forth in that Right-of-Way Contract on file in the office of the City Clerk as Document No. RR-270484-2

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the grant deed and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
