
ADOPTED ON MAR 07 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a contractual agreement with the SAN DIEGO UNIFIED PORT DISTRICT, to accept the contribution of \$100,000 from the Port District in exchange for the City constructing and operating a Day Center for the Homeless, under the terms and conditions set forth in the contractual agreement on file in the office of the City Clerk as Document No. RR- 270485.
