
ADOPTED ON MARCH 7, 1988

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to negotiate and execute, for and on behalf of said City, an agreement with BARRY M. SHAPIRO AND ASSOCIATES, for the design and implementation of Cross Cultural Training to all Fire Department personnel, substantially in accordance with the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 270490 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$63,700 from General Fund 100, Dept. No. 120, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreement and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
