Manager reviewed the proposals and interviewed four finalists and
the panel recommends that Price Waterhouse/RJA Management
Services be retained to provide services; and

WHEREAS, Price Waterhouse/RJA Management Services had conducted numerous successful executive searches for both public and private organizations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute an agreement with Price Waterhouse/RJA Management Services, for the purpose of recruiting candidates for a Deputy City Manager position, at a cost not to exceed \$20,000, pursuant to the terms and conditions of the agreement, on file in the office of the City Clerk, as Document No. RR-270491.

BE IT FURTHER RESOLVED, that the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$25,000 within the General Fund 100 from the Unallocated Reserve (605) to the City Manager's Department (040), for the sole and exclusive purpose of defraying costs in connection with the above executive search contract.
