
WHEREAS, the Public Facilities and Recreation Committee, at its meeting of March 7, 1988, recommended uses of certain City-owned vacant land to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Public Facilities and Recreation Committee recommendations on those City-owned sites numbered 20 - Area C, and 20 - Area D, as shown on that Document No. RR- 270493 in the office of the City Clerk, are hereby approved.

BE IT FURTHER RESOLVED, that the City Council, by making the above designation, in no way intends to bind itself to permanently utilize the property in accordance with the designation, and the Council specifically intends to be able to change the designation at any time or to utilize the property for any purpose determined to be in the best interest of the City at the sole discretion of the Council.

BE IT FURTHER RESOLVED, that the disposition of City-owned Site 455 is hereby continued to the Council hearing of March 21, 1988.
