RESOLUTION NUMBER R- **270499**

ADOPTED ON MAR 08 1988

WHEREAS, on September 14, 1987, the City Council by Resolution Number R-269272 authorized the City Manager to administratively abate a public nuisance by the removal of excessive rubbish and debris at the property located at 1307, 1309 Fern Street 3034 "A" Street, San Diego, California, more particularly described as:

Lots 8, 9, and 10 in Block 33 of South Park Addition in the City of San Diego, County of San Diego, State of California, according to the Map thereof No. 630, filed in the Office of the Recorder of said San Diego County, May 2, 1890;

and

WHEREAS, the Fire Department incurred total administrative and actual expenses of \$2,273.41 to hire a contractor to clear the rubbish and debris at 1307, 1309 Fern Street and 3034 "A" Street; and


WHEREAS, the record owner of the above-described property has been notified in writing of the public hearing to confirm the above costs of administrative abatement.

WHEREAS, the City Council pursuant to San Diego Municipal Code § 11.16 has reviewed the record of the costs transmitted by the City Manager and has provided the opportunity for anyone interested in the above-described property to contest the total abatement costs; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that it hereby confirms the cost of abatement of the property at 1307, 1309 Fern Street and 3034 "A" Street at \$2,273.41 and a special assessment in the amount of \$2,273.41 be levied against the above-described property.

BE IT FURTHER RESOLVED, that the Fire Department is hereby authorized and directed to collect this special assessment and provide proper documentation to the County Auditor before July 1, 1988, to incorporate this assessment on the municipal tax bill for this property to be collected in the same manner as ordinary municipal taxes, pursuant to Government Code §§ 38773 and 38773.5.
