BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF ELLEN BROWNING SCRIPPS PARK FENCING, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAR 14 1988, and bearing official Document No. W.O. 119028, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF ELLEN BROWNING SCRIPPS PARK FENCING.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller are directed and they are hereby authorized to add CIP No. 29-642 ELLEN BROWNING SCRIPPS PARK - FENCING as a CIP project to the Fiscal Year 1988 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$70,000 from CIP No. 90-245 CAPITAL OUTLAY FUND RESERVE - GENERAL - CONTINGENCY FUNDS to CIP No. 29-642 ELLEN BROWNING SCRIPPS PARK - FENCING.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$70,000 from Capital Outlay Fund 30245, CIP No. 29-645 ELLEN BROWNING SCRIPPS PARK - FENCING is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Council, for and on behalf of the San Diego Open Space Park Facilities District No. 1, hereby declares its intention to hold a hearing to determine whether or not the District should attempt to purchase certain property, approximately 5.41 acre of Rancho Mission Canyon #2, for open space park purposes.

2. That said parcel is more particularly described in that document on file in the office of the City Clerk as Document No. RR-270512.

3. That no park improvements to said property are presently proposed.

4. That on April 19, 1988, at the hour of 10:00 a.m., in the Council Chambers, City Administration Building, Charles C. Dail Concourse, 202 "C" Street, San Diego, California; the City Council will hear any persons interested in the matter of the acquisition of said property and will consider and finally act on the acquisition of said property.

5. That the owner or owners of said property may appear at the hearing and be heard orally, or by writing signed by them, and present evidence for or against the acquisition of said property by the District.

6. That a copy of this resolution shall be posted on the bulletin board of the City Administration Building and be published in a newspaper of general circulation, printed and published in the City once a week for two weeks, the posting and first publication to be on or before the 10th day prior to the day of hearing.
