
RESOLUTION NUMBER R- 270516

WHEREAS, in Closed Session on February 9, 1988, the City Council, by the following vote: Yeas, Districts 2, 3, 4, 5, 6, and 7, Not Present, Districts 1, 8 and Mayor O'Connor, approved the following; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be and he is hereby authorized and empowered to pay the total sum of \$95,340.63, in the settlement of each and every claim against The City of San Diego, its agents and employees, Superior Court Case No. 592276, Narciso Daguia, et al. v. The City of San Diego, et al. resulting from the personal injuries to Narciso Daguia, Lolita Daguia and Maria Daguia.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue three checks; one in the amount of \$55,000.00 made payable to Narciso and Lolita Daguia and their attorney, Scott E. Shaffman; a second check in the amount of \$35,000.00 made payable to Clerk of Superior Court of San Diego; and a third check in the amount of \$5,340.63 made payable to Farmers Insurance Group, in full settlement of the lawsuit and of all claims.
