WHEREAS, funds from the proceeds of the sale of Site 934 on Euclid Avenue were directed by the City Council to be placed in a trust fund, to be used if necessary to acquire land from the City Water Utility proposed to be used for the Mule Hill historical monument in the San Pasqual Valley; and

WHEREAS, it has been determined that said funds are not needed to acquire the Water Utility parcel since only a right-of-entry permit will be utilized for the historic monument; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the funds received by the City from the sale of Site 934 on Euclid Avenue are hereby authorized and directed to be deposited in the Capital Outlay Fund 30245.
