RESOLUTION NUMBER R- 270527

ADOPTED ON MAR 14 1988

WHEREAS, Lindbergh International Airport does not conform with State noise standards; and

WHEREAS, in order to continue operations at Lindbergh, the San Diego State Unified Port District must obtain a variance from the State of California; and

WHEREAS, noise from Lindbergh adversely impacts the quality of life in nearby San Diego neighborhoods; and

WHEREAS, pursuant to the Noise Variance hearing procedure, The City of San Diego, County of San Diego, Unified Port District, United States Marine Corps, United States Navy, Airport Coalition and Ms. Nancy Palmtag have entered into negotiations to identify measures to reduce noise around Lindbergh; and

WHEREAS, the City and County of Denver, Colorado, have adopted an Airport Noise Limitation Program to limit the airport noise exposure level at Stapleton International Airport; and

WHEREAS, the San Francisco Airport Commission has adopted a noise abatement regulation that will accelerate the use of "Stage 3" (quiet) jets at San Francisco International Airport;

NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that the Airport Noise Variance Negotiation Panel is hereby requested to: 1) review and analyze the Denver and San Francisco airport noise programs; 2) identify and analyze any other innovative

programs elsewhere in the United States; and 3) determine the applicability of these programs to Lindbergh Field, in particular their ability to reduce the number of Stage II (noisy jet) operations and reduce the area subject to noise levels of 80 CNEL or greater.
