

RESOLUTION NUMBER R- 270564

ADOPTED ON MAR 21 1988

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for IMPROVEMENT OF TIERRASANTA BOULEVARD BETWEEN SANTO ROAD WESTERLY TO I-15, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on MAR 21 1988, and bearing official Document No. W0119017, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for IMPROVEMENT OF TIERRASANTA BOULEVARD BETWEEN SANTO ROAD WESTERLY TO I-15.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute an agreement with the Navy to provide \$90,150 to share the cost for the IMPROVEMENT OF TIERRASANTA BOULEVARD BETWEEN SANTO ROAD WESTERLY TO I-15.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$260,150 (\$170,000 from FBA Fund 79005 and \$90,150 from Fund 63022 Navy agreement) from CIP No. 52-367 TIERRASANTA BOULEVARD - SANTO ROAD WESTERLY TO I-15 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


