
BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for an on behalf of said City, a consultants agreement with RECOVERY SCIENCES, INC., to modify a recycling options study and integrate the results of a waste composition study into a comprehensive five year recycling plan, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 270578-2.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$8,000 from Fund 100, Dept. 590, Org. 101, Account No. 4222, is hereby authorized, solely and exclusively for the purpose of providing funds for the execution of the above agreements and further authorizing the City Auditor and Comptroller upon advice from the administering department, to

transfer excess budgeted funds, if any, to the appropriate reserves.
